TELEMEDICINE – ASR & HAP

Amwell, a telemedicine benefit, is now available for ASR and HAP members. It offers greater access to doctors and urgent care visits for employees and their dependents. Amwell can be accessed online, by phone, or by downloading the Amwell app on your smartphone. Below are details on how to access this benefit according to your carrier.

- ♦ When visiting amwell.com, click "Sign Up" and enter the required information
- ◆ Amwell by phone, please call 1-844-733-3627
- ♦ When downloading the app, look for the Amwell logo
- ♦ When using Amwell, be sure to use the appropriate key code when registering:

ASR: asrcopaywaived

HAP: HAPMi

Navitus (Rx coverage) has implemented the following changes:

- Removal of early refill restrictions (conditions apply)
- · Waiving restrictions for out-of-network pharmacies
- · Allowing maximum extended day supply at the time of refill
- Permitting emergency refills

FOR HAP MEMBERS

HAP (Rx coverage) has implemented the following changes:

- Removal of early refill restrictions (conditions apply). Some refills up to 6 months
- FREE home delivery services for prescription drugs.
