**Christopher Korneder- Child Protective Services-Mandatory Reporting & Family Intervention Programs**

Christopher presented on the child protective laws and mandated reporting by all persons. He went over professional roles and showed information that you want to have available when reporting. He said to always make a referral if there is any sign of abuse. You can go online or call 855-444-3911.

**Anna Dillaway-Oakland Community Health Network**

Anna explained that OCHN is a provider service network. She shared their mission, vision and values. Anna also reviewed different types of support and how to provide treatment to those individuals ready for a change. There are different types of services, and many are specific to women.

The patient needs to be placed within 24 hours. These are evidence-based practices. They partner with Oakland Family Services for many of their programs. These services offered must be fully consented and cannot be forced. For a full list of their resources, please contact Anna.

### **Dave Roth-FIMR**

Dave discussed how they have a care review team that reviews infant deaths within Oakland County. Many of those deaths are sleep related so the team develops possible recommendations to eliminate these deaths. Dave's team is working with United Healthcare and Meridian to help with safe sleep issues within our community.

Dave mentioned that Cribs for Kids is looking for partners if anyone is interested. On June 4<sup>th</sup> there will be a drive thru event at Oakland Schools.
