Community events and services that have a fee or cost may be shared with the group if it aligns with the <a href="ECHO Inclusion/Exclusion Guidelines">ECHO Inclusion/Exclusion Guidelines</a>. Low cost and/or nocost events or services will be prioritized. Admins have the right to remove an event or post if the

## 4. Biking Infrastructure and Community Support

Jessica Williams from Healthy Pontiac, We Can! (HPWC!) sought insight from the group regarding bike lanes and community buy-in. Residents participated in the Complete Street study (which included sidewalk and safety audits) and Pontiac adopted a Complete Streets policy in January 2017. Bike lines were added on Saginaw St (November 2017) and on Perry Street (Winter 2018) in Pontiac. Pontiac residents have recently expressed frustration with the bike lane on Perry (2.5 miles) causing traffic congestion and have brought their concerns and frustrations to Pontiac City Council members. As a result, City Council asked MDOT to remove the Perry St. bike lanes. HPWC! would like to work with residents to maintain the bike lanes. Generated ideas were: increasing bike safety and road sharing information to residents and have HPWC! members attend district meetings about the lane changes. Ferndale Planning Manager Justin Lyons distributed a handout (included with the minutes) that was created by the City of Ferndale about sharing the road as a communications example.
