- If name changed since BC, then you can get name history from SSC and it would provide the link between the names since they have match
- For clients that lost their license but need an ID, they need to pay a fee (to the court), cannot just transfer from
 one to the other without surrendering license forever best case is to email James for further information on
 how to proceed
- Letter from Social Security identifying client can be accepted in lieu of actual SSC

MDHHS Central Registry Birth Certificates--Shelli Wood

• Homeless individuals send application and all documents in and then department will communicate what else is needed or what can be accepted



- MDHHS cannot waive a birth certificate name change fee (\$50).
 - o Depends on situation on documents might be necessary
 - Call Shelli Wood with questions on how to make a change to a Michigan birth certificate at 517-335-8660.
- HMIS IDs do not work as documentation to receive a birth certificate. Contact Shelli Wood for assistance at 517-335-8660.

MSHDA COVID 19 HCV Update on ID Docs--Lisa Kemmis

- HUD waived program requirements for entrance with SSC
 - O Client can self cert as long as it is obtained within 90 days
 - o For proof of age confirmation documentation as well
 - Documented on MSHDA 1890 form
- MSHDA verification of legal identity (MSHDA 111, provided by housing agent)
 - Proof of legal identity, third party can fill out second part, then can be signed in front of a MSHDA representative then notary is not required
 - Banks may notarize documents for free
 - Municipal ID is now acceptable (effective April 1)
