### 2. Secretary of State -- James Fackler

Secretary of State Office hours will adjust back to regular business hours – Monday-Friday, 9:00a.m.-5p.m. beginning October 1<sup>st</sup>.

Even if someone has a real ID from another state, they must show documentation to get a real ID from the State of Michigan.

## 3. Social Security Administration--Takeya Haugabook

Social Security Administration Offices are not open for non-appointments. In-person services are available to bring in social security card documents, but the client must schedule an appointment with their local office. Call your client's local office and ask about express appointments.

If someone needs a social security card, they must know their social security number and have an ID. They can fill out a social security card application online for free.

COVID-19 vaccine cards can now be used as a form of identification for documents.

Drop boxes are still available to use.

### 5. MSHDA COVID 19 HCV Update on ID Docs—Deidre Butterworth

HUD waived program requirements for entrance with SSC

- 1. Client can self cert as long as it is obtained within 90 days
- 2. For proof of age confirmation documentation as well
  - 1. Documented on MSHDA 1890 form

MSHDA verification of legal identity (MSHDA 111, provided by housing agent)

- 3. Proof of legal identity, third party can fill out second part, then can be signed in front of a MSHDA representative then notary is not required
  - 1. Banks may notarize documents for free
- 4. Municipal ID is now acceptable (effective April 1)
