- 2) You must begin testing the morning after the date of this order.
- 3) You must notify the court where you have chosen to test within 24 hours. Court approval is required to change testing agencies.
- 4) All testing must take place prior to 9:00 am unless specified in your court/probation order.
- 5) Please bring the following with you:
 - a. Bring cash to your initial intake appointment; intake fees can vary from \$25 to \$30 and random testing could cost anywhere from \$4- \$25 depending on the substance you are being tested for.
 - b. A picture ID. If you do not have one, please speak with a clerk or a Probation Officer
 - c. A copy of your court/probation order.

Questions and Answers:

- **What if I miss my morning drug test?**
 - You must submit the drug test that afternoon (if open) or the following morning.
- **What if I'm late/miss my morning PBT or ETG testing?**
 - You must submit an ETG test that afternoon (if open) or the following morning.
- **What if I test positive for drugs?**
 - You must send the sample to the lab before leaving the testing agency. If you fail to send the sample to the lab during that time, the court will assume the positive test was valid.
- **What if I test positive for alcohol?**
 - You must take an ETG before leaving the testing agency. If you fail to submit to an ETG during that time, the court will assume the positive test was valid.
