You have been Court ordered to complete drug / alcohol testing:

The testing agency must:

- Be open 7 days a week
- Employ staff properly trained to operate a PBT
- Facility employee must observe and monitor every sample provided
- Automatically lab confirm all positive tests
- Test each sample for creatinine level and adulterants
- Fax positive levels and no shows to the Probation Department at (248) 299-7891
