## A. Purpose

This report summarizes the activities undertaken to implement the Rouge River Collaborative Public Participation/Involvement Program (Plan) which was approved by the Michigan Department of Environment, Great Lakes and Energy (EGLE) in March 2017. The Plan is part of the municipal separate storm sewer system (MS4) permits for several communities in the Rouge River watershed. The report includes activities implemented by or on behalf of members of the Alliance of Rouge Communities (ARC) from January 1, 2020 through December 31, 2021.
