What this grant does not do:

- Does not provide money for payment of water/sewer bills
- Does not provide money for investment in infrastructure

Matrix of Community Characteristics — Differences



Categories	Royal Oak Township (Pop. 2,411) Median Income: \$28,311	Pontiac (Pop. 60,400) Median Income: \$33,568
Size of System	Smaller System - a small change in expenses or a small change in projected consumption can have a much bigger impact on rate increases. For example, a decrease in projected consumption from one non-residential customer in Royal Oak Township caused a 3% increase in rates.	Larger System
Collaboration with Neighboring Communities	No similar opportunities for Royal Oak Township	Pontiac has been able to capitalize on opportunities to collaborate with neighboring communities to reduce expenditures (i.e. NOCWA and COSDS flow to CRWRFF). This has enabled WRC to accelerate the replacement of aging infrastructure and improve customer service in Pontiac.
Sewer System	Combined sewer system means Royal Oak Township pays sewage disposal fees to two entities (GLWA and GWK). Sewer bills are more burdensome to customers than water bills.	Separate sewer system means that Pontiac pays sewage disposal fees to one entity (CRWRRF).
EPA Affordability Guidelines	57% of households have water and sewer bills above the EPA affordability guideline.	37% of households have water and sewer bills above the EPA affordability guideline.
Residential Water and Sewer Bills	Average monthly residential water and sewer bill is \$115.	Average monthly residential water and sewer bill is \$82.
Fixed Costs	Royal Oak Township has little to no commercial properties that would offset costs for residents by paying a higher fixed fee.	Pontiac has more non-residential properties that pay fixed fees.

Matrix of Community Characteristics — Commonalities



Categories	Pontiac and Royal Oak Township			
Aging Infrastructure	Aging infrastructure needs repair and upgrade, and customers are unable to afford these upgrades.			
Lead	Lead service lines that need to be replaced.			
WRAP Program	Need to better message the WRAP program to residents, especially seniors who don't use internet as often as other customers.
