## Majority caucus members issue statements in response to County Executive Coulter's State of the County address

**February 12, 2020, OAKLAND COUNTY, MI.** – Members of the Democratic Caucus have issued the following statements in response to County Executive David Coulter's State of the County address:

**Commissioner Kristen Nelson** – District #5 (Keego Harbor, Orchard Lake Village, Sylvan Lake, Waterford Township, West Bloomfield Township):

"David Coulter's message of 'Oakland Together' is absolutely right," Nelson said. "Let's set aside the needless partisan bickering and get to work solving problems that are impacting real people."

**Commissioner Gwen Markham** – District #9 (Northville, Novi, Novi Township):

"Our oak tree program is a great way for all residents to celebrate our county's birthday while investing in our future," Markham said. "Each oak tree planted will remove four tons of carbon over its lifetime. Dave Coulter and the Commission are working together to build a new clean energy agenda for Oakland County."

## Commissioner Angela Powell – District #10 (Pontiac):
