March 19th, 2018

The meeting of the Oakland County Library Board was called to order at 3:07 p.m.

A. Circuit Court Accommodation

Laura Mancini informed Board members about a recent request she received from the Oakland County Circuit Court to provide a pro se litigant with a disabilities accommodation—access to a Library computer having Adobe PDF reader software, plus headphones.

B. Bulletin Board Policy

The Law Library has been receiving more frequent requests from outside groups and individuals to post materials on its public bulletin boards. However, the Library doesn't have a formal, written policy to address which content is displayed on these bulletin boards. Laura Mancini asked the Board to review a draft policy that would govern this practice.

<u>Resolution #18-06</u>: Robert Tera moved to revise the draft policy statement to read: "Due to limited space, only items related to the Adams-Pratt Oakland County Law Library's mission and Oakland County Government services will be accepted for posting on its public bulletin board." Shelley Taub seconded. Motion carried.

- The Law Library has initiated a special information campaign to reach out to Oakland County's court-appointed criminal defense attorneys to enhance awareness of the Library's assistance and resources.
- Laura met with the Oakland County Bar Association to explore future collaborative projects with the Law Library.
- Laura met with the chairs Research & Writing subgroup of the Oakland County Bicentennial Committee to inform them about historical materials in the Law Library's collection that may support their work.
- The Law Library recently purchased another legal research database subscription, Ebsco Legal Information Research Center, which also includes remote access.
- Information Technology has updated the interface of the Law Library's website to make it even more compatible for mobile device usage.
- The Library of Michigan has purchased another membership for library trustees in *United for Libraries*, a division of ALA, which offers free, online resources for trustees.
- The Oakland County Bar Foundation has updated its mission statement; and is still committed to supporting the Law Library.
- The TLC Network filmed a portion of an upcoming episode of *Long Lost Families* at the Law Library.
- 17 legal aid clinics were held at the Law Library from January 25th to February 27th, 2018.
