CY 2021 YEAR END ACTIVITY REPORT - DIA

Julie McFarland, Public Affairs Officer, Detroit Institute of Arts (DIA), provided a report and presentation to the Oakland County Art Institute Authority (OCAIA) members summarizing the year-end activity for the DIA in 2021. Emphasis was placed on the four categories of the existing service agreement: free general admission, school services and teacher program, the senior program, and community partnership programs while highlighting that the DIA met their goals for those programs in 2021.

A discussion was held regarding the general admission numbers and capacity limits, especially as it pertains to the status of COVID-19. Masks are no longer required in the museum, but they are still available free of charge to patrons and employees who wish to use them. The DIA has been able to accommodate walk-ins and has not had issues with hitting capacity limits.

Salvador Salort-Pons, Director, DIA, reviewed the DIA's current service agreement compliance. The current agreement term expires in December 2022, and the next agreement term will run from January 2023 – December 2032. He expressed his wishes that increased parity among the three participating counties be included within the next 10-year agreement.
