LANDING AND PARKING FEES

Landing fees shall be charged for all transient aircraft using the landing facilities at the Airport, except military or government aircraft, or as otherwise approved by Airport Administration. All weights are based on Maximum Gross Takeoff Weight (MTOW) as established by the FAA. Payment of a landing fee shall include parking on the Terminal ramp for up to six hours.

The 2021 land lease rate for airport property is \$.30 per square foot annually, effective 6/1/2023.

J. DAVID VANDERVEEN CONFERENCE CENTER RENTAL RATE - OCIA

The J. David VanderVeen Conference Room located in the OCIA terminal building can accommodate up to 100 people and is available for public meetings and gatherings Monday through Friday, during normal business hours. The room is equipped with business center amenities. Rental rate is \$300 for a period of four hours, plus \$75 for each additional hour. After-hour and weekend use must be approved by the Airport Manager prior to scheduling and additional fees may apply. A refundable security deposit is also required. Interested parties can reserve the space with the Administrative Office at (248)666-3900.

OPERATOR FEES

- 1. Car Rental Concession fees shall be charged at a rate of \$200 per month or eight percent (8%) of gross receipts per month, whichever is greater, effective 7/1/21.
- 2. Fuel Flowage fees shall be charged monthly at a rate of \$.08/gallon for Avgas and \$.10/gallon for Jet fuel for each gallon of fuel delivered to Oakland County Airports. Minimum annual fee is \$25,000.
