6. <u>Detroit Arsenal Regional Defense (DAR2) Risk Assessment</u>

Shannon Bergt with U.S. Army Garrison – Detroit Arsenal provided the Board with a presentation on energy resilience as it pertains to the Drainage District (attached). She gave a brief background on the history of the Detroit Arsenal Regional Defense Assessment of Resilience (DAR2) and expressed the importance of this program due to more frequent and severe disasters that affect the critical infrastructure in Macomb County and surrounding communities. Due to this infrastructure and the importance of its security, DAR2 would be extremely beneficial to the Drainage District.

Ms. Bergt walked the Board through the DAR2 process and advised that there are 3 phases in which the DAR2 process goes though. First, they perform the initial outreach to community stakeholders and identify the critical infrastructure within the community. After the initial outreach, they would then collaborate with the community stakeholders, which would include a stakeholder workshop to identify the vulnerabilities that need attention. The last and final step would be to make recommendations for resilience improvements implementation.

Ms. Bergt touched on the benefits of having the Office of Local Defense Community Cooperation (OLDCC) as a partner, which would make available different funding opportunities for projects that would fall within the scope of the study. She also emphasized that the goal of this process is to do everything possible to protect the region's infrastructure and although there is no Board action to move forward at this meeting, she advised that a letter would be put together and presented to the Board next month to move forward with the initial outreach. Discussion ensued as to the different funding opportunities and the effects of the collaboration.

Intercounty drain project creates new hike/bike path

Walkers, joggers and bicyclists have a new scenic route to enjoy in Macomb County as part of a recently completed intercounty drain project to halt erosion near a closed landfill.

The new 1.35-mile hike/bike trail is located along the Red Run Drain and the Sterling Relief Drain in the city of Sterling Heights. It branches south from the popular Freedom Trail hike/bike path on Metropolitan Parkway, curves behind Freedom Hill County Park and continues west to Schoenherr Road. The 100-acre park, opened in 1974 on a site that includes a closed 40-acre landfill, is best known as the home of the Michigan Lottery Amphitheatre.

"The trail makes a beautiful area accessible to the public. It's a suburban area but you feel like you're up north," Macomb County Public Works Commissioner Candice S. Miller said.

The Red Run drains much of southeast Oakland County and carries flow through part of the City of Warren and crosses into neighboring Sterling Heights. Before connecting with the Clinton River – which flows into Lake St. Clair – the Red Run Drain is met by a tributary, the Sterling Relief Drain.

Unfortunately, the banks of the Red Run eroded significantly over the years behind Freedom Hill County Park, particularly on the north side. In some spots, the erosion crept to within 10 feet of the closed landfill.

The idea for a non-motorized trail in that location was added during plans to stabilize the north bank of the Red Run Drain.

As part of the drainage work in the open channel drain, excavation contractor L.J. Construction, based in Clifford, Mich., started work in spring 2022 by removing sediment from the Red Run. The company also painstakingly built three new "J-hook" peninsulas just beyond where the Sterling Relief Drain flows into the Red Run. Known as "J-hooks" because of their shape, each is made of thousands of limestone boulders, and they work in unison to direct strong flow – particularly after heavy rain events – toward the center of the open channel for a long-term improvement away from the banks.

In recent years, maintenance vehicles created a rough path in some areas near the north bank behind the park and along the Sterling Relief Drain. However, it was not open to the public and was being washed away by erosion.

The Public Works Office and the Macomb County Department of Planning and Economic Development explored the idea of developing a hike/bike trail that could be shared with the public behind Freedom Hill and west to

Schoenherr Road. The Red Run Intercounty Drain Board and the Sterling Relief Drain Board approved the plan, and Sterling Heights officials endorsed it.

The 1.35-mile path along the north bank was carved, and top soil was used to make the trail. The planting of 475 trees, 2,500 shrubs and 4,000 native pollinator plants along the north side of the Red Run Drain and within the Sterling Relief Drain began this year and will be completed in spring 2023. Once fully established, the plantings help prevent erosion and act as green infrastructure to capture and filter an estimated 200,000 gallons of storm water runoff per year to remove phosphorus and nitrogen. It's also part of the Green Macomb Urban Forest Partnership and will increase habitat biodiversity.



During strong or higher flow, especially after heavy rain, the three completed "J-hooks" at the Red Run Drain work in unison to prevent erosion of the drain bank by directing the flow toward the center of the channel.

The \$1.3 million drain restoration was funded by the 22 communities in the Red Run Intercounty Drainage District. The trail development and plantings were funded with a \$300,000 grant from the National Fish and Wildlife Foundation, and \$260,000 in state highway funds to Macomb County.

Other partners in the project included: Macomb County Department of Roads; Lake St. Clair CISMA; Clinton River Watershed Council; Oakland County Water Resource Commissioner's Office; South Macomb Disposal Authority; Consumers Energy; and engineering consultants Hubbell, Roth & Clark.

County and city officials touted the combined environmental, recreational and storm water management aspects of the project.

Macomb County Executive Mark Hackel said the project also has economic benefits. Noting that the Red Run Drain connects to the Clinton River, which flows into Lake St. Clair, Hackel said clean lake water is important.

"Leveraging the natural beauty of Macomb County and the creativity of our environmental champions, we are developing transformational, recreational and environmental projects. This trail and restoration plan has helped us reimagine an underutilized area that is quickly becoming a celebrated community asset. Whether you are an avid runner or someone who loves nature, we welcome you to come and explore," Hackel said.

"This trail project, born out of need for an access road along the Sterling Relief and Red Run drains, is a gift to our community in a lot of ways," said Sterling Heights Mayor Michael Taylor. "The trail creates yet another non-motorized asset for our community, provides an appealing option for walking, running and biking and aligns well with Sterling Heights' commitment to sustainability. We're grateful for the intergovernmental collaboration we have that allow projects like this to happen."

The Red Run Drain Board includes Miller, Oakland County Water Resources Commissioner Jim Nash and Chairman Michael Gregg, intercounty drain program manager at the Michigan Department of Agriculture & Rural Development.

"In addition to the collaboration of the community and county stakeholders, on behalf of the Red Run Board I want to acknowledge HRC for their engineering design, perseverance through the protracted EGLE/U.S. Army Corps permitting process and overall construction management that made this project possible," Gregg said.

"This project brings all the aspects of our commitment to improving our infrastructure. We are ensuring the long-term sustainability of our storm water system while using green infrastructure and community collaboration to create a truly enjoyable natural atmosphere and recreational experience," said Nash.

The Sterling Relief Drainage District Board includes Miller, Macomb County Commissioner Joseph Romano and Macomb County Department of Roads Director Bryan Santo.

Dear Board Members:

The United States Army Garrison - Detroit Arsenal (USAG-DTA) requests to partner with the Red Run Intercounty Drain Drainage District (RRIDDD) in a grant from the Department of Defense, Office of Local Defense Community Cooperation (OLDCC), Installation Resilience Program. This request is a direct result of findings and recommendations from the OLDCC funded at the Detroit Arsenal Regional Defense Assessment of Resilience (DAR2), (Enclosure).

The Department of Defense (DoD) Climate Risk Analysis has determined that the planet's changing climate has a significant impact on Defense Department's missions, plans, supply chains and installations. Therefore, DoD has elevated climate change as a national security priority; integrating climate considerations into policies, strategies and partner engagements. The DoD and The Army's decisions around climate change and those of neighboring communities are intrinsically interconnected. The DoD is working to ensure climate assessments are based on the best available, validated, and actionable science that informs the most likely climate change outcomes. Data sources and models must be updated and monitored with consideration to the national energy, security and operational impacts.

The scope of this grant will include two planning charettes with key stakeholders, a comprehensive regional Hydrologic and Hydraulic (H&H) Study, predictive modeling for the region to include, but not limited to, the RRIDDD and major utility infrastructure, and a comprehensive report with actionable recommendations for regional flood mitigation measures.

Under this request, the RRIDDD would act as the non-federal partner with the U.S. Army Garrison - Detroit Arsenal for the Federal Fiscal Year 2023, Phase I and Federal

Fiscal Year 2024, Phase II grants. Under both phases of this request, the RRIDDD would apply for an OLDCC Installation Resilience grant, act as the grant administrator, and provide a minimum of a 10% funding match; which can consist of staff time, cash, or material donation. The requests are as follows:

- a. Federal Fiscal Year 2023, Phase I request to OLDCC Installation Resilience Program for the DAR2 H&H study for \$750k with estimated responsibility of \$75k to the RRIDDD in match.
- b. Federal Fiscal Year 2024, Phase II request to OLDCC Installation Resilience Program for the DAR2 H&H study for \$750k with estimated responsibility of \$75k to the RRIDDD in match.

The USAG-DTA, the OLDCC, and the United States Army Corps of Engineers anticipate that the findings of the Phase I H&H study and the Phase II H&H report will provide actionable items based on science and predictive modeling. These courses of action will provide the basis for further partnership opportunities, funding requests and projects for climate risk mitigation projects with regional impact.
