• \$50/night per group area – payment due at time of booking. Additional fee of \$5/person per night. Cancellation requires 14 days advance notice. Rate is not valid for holiday/special events. This is typically an off-season rental.

<u>2024 Terms and Conditions - Group Camping Area</u> <u>Addison Oaks and Groveland Oaks campgrounds</u>

- <u>Camping Fees</u>. A \$250 down payment must be paid at the time a reservation is made. This payment will be applied to the total camping fees. All camping fees (less the \$250 down payment) are due <u>30</u> days prior to the start of the reservation. If the camping fees are not paid <u>30</u> days or more prior to the start of the reservation, the reservation is subject to cancellation by the Park and the down payment will be forfeited.
- 2. <u>Contact Person</u>. Only one person/entity shall make the reservation and payment for the group campsite area. There shall be one Contact Person listed per group campsite area. The Contact Person is responsible for reviewing the check-in list, collecting all camping fees from other group members if necessary, and making the payment (cash or credit only) to the Park.
- 3. Addison Oaks Only: All campers will be checked in as they arrive.
- 4. <u>Vehicles</u>. No more than two vehicles per campsite are permitted. Two vehicles are included in the cost of the reservation.
- 5. <u>Transfer</u>. Reservations cannot be exchanged or transferred to another person/entity or date.
- 6. Cancellation. If notice of a cancellation is received:
 - 1. <u>90 or more days</u> prior to the start of the reservation, all camping fees received by the Park will be refunded.
 - 2. <u>Less than 90 days</u> prior to the start of the reservation, the reserving person/entity forfeits the down payment.
 - 3. <u>Less than 30 days</u> prior to the start of the reservation, the reserving person/entity forfeits the down payment, <u>and</u> 50% of the additional fees collected.
- 7. <u>Change to Rental Fee</u>. The group area rental fee is subject to change after a reservation is made. If a rental fee is increased after a reservation is made, the person/entity agrees to pay the difference. The Contact Person will be responsible for making this payment if necessary.
- 8. <u>Damage</u>. If there is any damage to any campsite or the group camping area, the Contact Person is responsible for the cost of repair.
- 9. <u>Park Rules and Regulations</u>. All <u>Oakland County Parks Rules and Regulations</u> must be followed. Please see the <u>OCP General Information and Regulations booklet</u> for the full set of camping rules. The booklet is available online at OaklandCountyParks.com or at the contact station.
- 10. <u>Violation and Fees</u>. Park staff may remove any person for violation of <u>Park Rules and Regulations</u>. If a person who is removed from the Park due to violation of Park Rules and Regulations, all fees paid to the Park shall be retained by the Park and no fees shall be refunded.
