

FOOD PROTECTION MANAGEMENT CERTIFICATION COURSES - WINTER 2023



Food Protection Management Certification

This course covers the following principles: causes and prevention of foodborne illness, bacteriology, safe food handling techniques, safe food storage, cleaning and sanitizing procedures, pest control, employee personal hygiene, employee education and motivation, and management's rights and responsibilities. This program satisfies the food protection management certification requirement for the Oakland County Health Division (OCHD) Sanitary Code, Article IV, as well as the Michigan Food Law, Act 92 of 2000.

Food Protection Management Recertification

This course is designed for students who have already received a certificate from a previous food protection management certification course and need to become recertified due to an expired certificate. This course covers the same material as the 16-hour course; however, it is in an abbreviated format. This class is designed to have four (4) hours of course lecture and review.

If a certificate is more than ten (10) years old, it is recommended that the full 16-hour certification course be taken. Students **MUST** provide a copy of their previous certificate from a State of Michigan approved food protection management certification course at the time of registration.
