TO THE OAKLAND COUNTY BOARD OF COMMISSIONERS - FINANCE COMMITTEE:

The attached Apportionment of Local Tax Rates was prepared by the Equalization Division of the Department of Management and Budget, under the supervision of the Department of Management and Budget and Oakland County Board of Commissioners Finance Committee.

The certificates, statements, papers and records submitted by the various townships, cities and villages were examined, and the enclosed rates represent a compilation of those documents. The certified rates, as adjusted by Headlee M.C.L. 211.34d, 211.34e and Truth in Assessing M.C.L. 211.34, are set for all townships, cities, and villages in Oakland County with the exception of the Schoolcraft Community College rate which, contrary to the recommendations of Oakland County Equalization and Oakland County Corporation Counsel, has not been adjusted by Headlee.

Of special interest on page 1 is the Summary of the Estimated Tax Levy by the various taxing authorities. These recaps depict the average tax rate and estimated total levy.

The attached Resolution, if passed by the Oakland County Board of Commissioners, will authorize the Equalization Officer to sign the several tax certificates on which the attached tabulation was based. The action thereby authorizes and directs the various assessing officers to spread the rates against the 2023 taxable valuation.

IN RE: DEPARTMENT OF MANAGEMENT AND BUDGET – CHANGES TO FY 2023 APPORTIONMENT OF LOCAL TAX RATES

To the Oakland County Board of Commissioners

Chairperson, Ladies and Gentlemen:

WHEREAS The Oakland County Equalization Division has prepared this report based on a detailed review of tax levies in Oakland County for County, Townships, Villages, Local School Districts, Intermediate School Districts, and Community Colleges. The statutory responsibility of the County Board of Commissioners is contained in Section 37 of the General Property Tax Law, Public Act 206 of 1893 as amended; and

WHEREAS in accordance with M.C.L. 211.37, the Oakland County Board of Commissioners is required to meet and certify such millage rates and to publish the Apportionment Report of Local Tax Rates incorporating those rates; and

WHEREAS pursuant to Section 36 of the General Property Tax Law, Public Act 206 of 1893 as amended, After a millage is certified pursuant to subsections (2) through (4), the appropriate county board of commissioners shall meet and direct or amend its direction for the spread of millages by local units in the county pursuant to the certification or amended certification; and

WHEREAS the attached certified rates are subject to M.C.L. 211.36 which allows additional millage to be voted up to and including December 7, 2023 for schools and, if adopted, up to and including November 7, 2023 for taxing jurisdictions, as specified in said section.

NOW THEREFORE BE IT RESOLVED that the Oakland County Board of Commissioners approves the attached certificates, in compliance with the General Property Tax Act and directs the various assessing officers to spread the rates against the taxable valuation set forth herein for 2023.

BE IT FURTHER RESOLVED that the Oakland County Board of Commissioners, directs the Equalization Division to sign the several tax certificates on which the attached tabulation was based.

BE IT FURTHER RESOLVED that the Oakland County Board of Commissioners, in compliance with the General Property Tax Act and the 50 mill limitation, directs the Equalization Division to revise the apportionment report for 2023 as follows:



