

# Senior Volunteerism Grant Informational Session

February 13, 2024



## **Background**

- The coronavirus pandemic has had detrimental impacts on the social and emotional well-being of seniors in Oakland County. The impact of the virus on older adults went beyond a higher risk for serious infection. It also revealed limited access to care for all health conditions, as well as considerable social and economic hardships.
- On Sept. 1, 2022, the Oakland County Board of Commissioners passed Resolution #22-280 appropriating American Rescue Plan Act funding to support the Oakland Together Senior Initiatives. These initiatives include grants for non-profit organizations that provide senior-centered services in Oakland County. The funds can be used for a variety volunteer-related of to increase.

## **Eligibility Requirements**

- Projects must be eligible under the United States Treasury guidelines for American Rescue Plan Local Rescue Recovery funding.
- Must be a non-profit that provides senior-centered services, such as food delivery, transportation, and home repairs.
- Existing senior volunteer program and is not a recipient of any Oakland County ARPA funds in the past.
- Must describe how the proposal in the application for funding to the Senior Centers Grant Program will be used to make long-term improvements for the senior citizens in your community.
- Must describe the impact of the COVID-19 pandemic on your program and how that influences your plans under this grant.
- Must include an implementation plan and timeline for using the grant funding.
- The maximum grant amount is up to \$10,000.

## Eligibility Requirements Cont.

- Grant funding can be used on the following: background check screening for volunteers, outreach
  planning to increase the number of volunteers, and volunteer training.
- In accordance with the ARPA reporting required of the county, grantees shall submit quarterly reporting to Oakland County on the use of the grant funds. A template will be provided to grantees.
- Grantees shall submit a final report by the end of the agreement or within 30 days after Project completion, whichever date is sooner, on the grant funds including:
  - Project completion report.
  - Full accounting of its expenditure of grant funds.
  - Certification of its use of grant funds and fulfillment of the terms of the Agreement.
- Funds received from this grant must be used by Dec. 31, 2026.

- Background Checks Screening
- Outreach Plan to Increase Number of Volunteers
- Volunteer Training
