2024 Late Fee Forgiveness Program

The 48th District Court, located at 4280 Telegraph Road, Bloomfield Hills, MI, will hold a late fee forgiveness program commencing May 1, 2024, and ending on June 14, 2024. The court will waive late fees and penalties for **civil infraction cases only**, that were issued within the jurisdictions of the 48th District Court. The original fine, cost, and Secretary of State clearance fee must be paid in full during this period in order to use this program. Payment plans **will not** be established.

Bench warrants issued for failing to appear at a show cause hearing for non-payment of a civil infraction will be cancelled and bench warrant fees will be waived, only if the original fine, cost and clearance fee are paid in full during this period.

Payments may be made with money orders or certified checks via U. S. mail to the court at the address above. Money orders and certified checks may also be placed in the drop box near the front door of the courthouse. Payments by personal and business checks **will not** be accepted. Cash payments may be made inside the courthouse.

Online payments can be made with a credit or debit card at www.48thdistrictcourt.us. Please note that a service fee is added to all online payments. You will need your citation number and the amount owed.

Please call the court at 248-686-5150 or 248-686-5148, Monday through Friday, between 1:30 p.m. and 4 p.m., to confirm your civil infraction is eligible for the program and to obtain the exact amount owed.
