#### Sustainable Procurement

There's a growing emphasis on sustainability in government procurement. The procurement officer will be leading initiatives to purchase from green suppliers, integrate sustainability criteria into procurement decisions, engage in contracts that focus on environmental benefits, and oversee contracted sustainability deliverables.

Increasing diversity among suppliers is an important goal for Oakland County. The procurement officer will be creating or expanding programs to ensure more opportunities for minority-owned, women-owned, and veteran-owned businesses.

#### **Strategic Sourcing**

Developing a strategic sourcing plan that aligns more closely with the longterm goals of the Oakland County to help ensure that procurement activities support wider policy objectives, such as environmental sustainability, economic development, and innovation.

#### Contract Management Efficiency

Improving contract management processes to ensure that contracts are managed effectively throughout their lifecycle can lead to better outcomes, fewer disputes, and more strategic vendor relationships.

#### **Performance Measurement**

Establishing clear metrics and benchmarks for assessing the performance of the procurement function and its impact on the overall efficiency and effectiveness of Oakland County to assist in continuous improvement.
