A Letter From the CLEMIS Advisory Chair

I would like to thank Printrak, Motorola, and SCA executives for availing themselves at our September 27th, 2001 Advisory Board meeting. It was a difficult message they were presenting; the announcement of another seven-month delay in delivery of our Law Enforcement Records Management System. Notwithstanding our desire to cooperate with the Motorola Corporate group in a positive manner, I find it necessary to clear the record on some statements made by their executives at the meeting.

Mr. Lyons of Printrak, Int'l explained that the Records Management System would be delayed yet again and some of the causes delaying the delivery were because the "functions" were not clearly developed by CLEMIS. I respectfully disagree with Mr. Lyons characterization; I, along with other Chiefs, worked with CLEMIS staff to provide clear, detailed, and specific functional requirements. The RFP is a record of just how detailed those functional requirements are.

Mr. Lyons also asserted that originally Printrak planned to deliver their current version of Printrak RMS (Records Management System) software and meet the contract with a series of subsequent multiple releases. The key to the allegation is that CLEMIS changes caused project delays, increasing development costs from \$600 thousand to \$2.3 million. The statement that this was an unanticipated development and, therefore;

CLEMIS caused delays in the Records Management delivery, is falicious. I have read communications sent to CLEMIS staff as early as November of 1997. Printrak management was fully aware they could not deliver the CLEMIS RMS without a complete rewrite.

Finally, Mr. Lyons suggested that CLEMIS staff chose to change mobile data vendors and that Printrak did not plan on developing the RMS for Field-Based Reporting. The fact is; CLEMIS staff reported to all of us in the Advisory Board meeting of January 18, 2001 that the original mobile data vendors stock dropped from \$18 per share to about \$2 per share, they were closing offices, and laying off personnel. Further, the vendor was one year behind on delivery, and Printrak was indicating the "Best of Breed" vendor was not responsive. Indicators seemed to show corporate instability, which questioned the wisdom of continu-

ing business with that company. The selection for the change was made by CLEMIS, and Printrak concurred.

The CLEMIS contract with Printrak is over 7.8 million dollars, Printrak has the "Turnkey" or total responsibility to deliver ALL contracted functions. The attempt to shift responsibility to CLEMIS failed because it wasn't supported by fact.

My desire, and I believe I speak for the majority of the CLEMIS membership, is to move forward in a cooperative manner with Motorola with an accurate record.



Automated Vehicle Location Crime Reporting By Robert Daddow, Asst Deputy County Executive



The County recently hired additional consultants to accelerate the deployment of the automated vehicle location and crime reporting (that is, Geographic Information System). A plan has been developed and the system configured for the unique characteristics of a consortium such as CLEMIS. Deployment of the AVL should occur in December. The County should have a prototype of the crime reporting tools and proposed organizational implications by mid November.

The CLEMIS vision is to empower criminal justice and public safety agencies to maximize the use of collected data, so they may enhance their daily operations and perform comprehensive planning.
