THERE ARE TWO TYPES OF SURROGACY

- Traditional surrogacy, which means that the person with a uterus who provides the egg also carries the baby
- Gestational surrogacy, where embryos created from eggs and sperm from the intended parents or donors are implanted into the surrogate’s uterus

WHAT ARE THE BENEFITS OF SURROGACY?

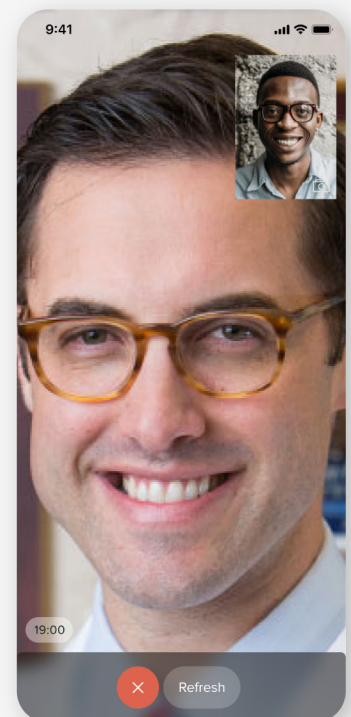
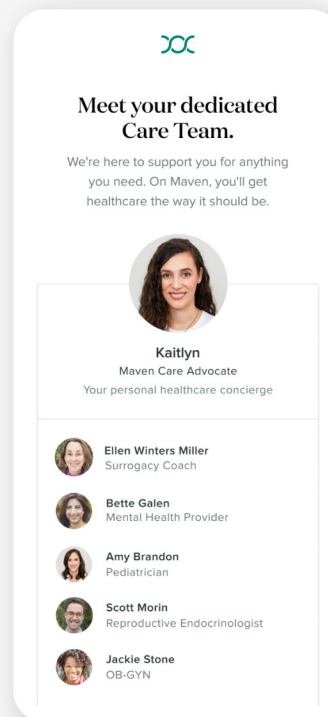
- **Accessible pathway to parenthood:** Surrogacy can be a fulfilling way to have a family and is likely to be successful—according to the [CDC](#), surrogacy has the highest success rate of any fertility treatment.
- **Increased involvement:** Surrogacy allows the intended parents to be involved in the pregnancy process, being present for key moments like embryo transfer, prenatal appointments, and birth.
- **Lower legal risk factors:** A legally-binding contract is negotiated and signed before the embryo transfer, ensuring that all parties know exactly what to expect during the process.

WHAT ARE THE CHALLENGES OF SURROGACY?

- **Budget:** Surrogacy can be extremely cost-prohibitive, with the total cost ranging from \$100,000 to \$200,000 in the U.S. Some companies may offer financial support or reimbursement for surrogacy.
- **Legal challenges:** Surrogacy is not legal in all 50 states—it's currently illegal to be a gestational carrier in Michigan, Nebraska, and Louisiana. [Surrogacy laws](#) vary drastically from state to state, meaning the process looks different depending on where you live. LGBTQIA+ couples may also have to overcome extra hurdles to have both parents recognized as legal guardians.
- **Age limitations:** Most surrogacy agencies have an age limitation of intended parents of a maximum combined age of 110 for couples, and 54 for single individuals.
