Welcome: Making Connections and Introductions

Chad welcomed the group at large.

Current Policy Landscape & Local Impact

- Proposed SNAP-Ed cuts impacting United Community Family Services, Oakland County
 Health Division, and Gleaners. The next round of funding tentatively will start on October 1,
 2025; Michigan Fitness Foundation (funder) told grantees to continue operations as normal
 with more details come in June.
- United Way shared the Emergency Food and Shelter Program (EFSP) is on hold and this is a potential loss of \$400,000 across Oakland County.
- Senior Market Fresh is on hold until June 1, 2025.
- Forgotten Harvest reported declines in rescued food; Lighthouse shared Meijer is no longer donating produce and is composting it instead.
- Michigan School Meals was included in the Governor's FY26 budget but cut from a House proposal (HB 4162). Fewer students may automatically qualify for free/reduced costs meals due to proposed SNAP and Medicaid cuts. This would increase financial need for additional state funds to cover the balance. Currently, Michigan school districts provides universal free school meals and uses state funds to cover the remaining reduced fares and/ or full-priced meals for students. Title 1 funding decreasing would also impact categorical eligibility for students.





Local Efforts and Strategies: What can OCFPC do?

- Seek joint advocacy opportunities, for example, around SNAP-Ed
- Continue communication on policy and funding updates
- Promote the Oakland County Food Landscape Study when released, and share with local elected officials for as evidence when discussing food policy issues and impacts
- Explore an OCFPC social media account to share advocacy opportunities
- Create a charter that is more nimble and responsive to address emergent concerns and issues
- · Look to alternative industries for funding opportunities
- Seek to answer, "What does the food policy council membership what to contribute?"

Partner Updates

- Lori (Oakland Schools): Will be sending out a survey to collect information on summer feeding sites. Lori will share informational flyer when details are complete. Meet Up, Eat Up is now referred to as SUN Meals. Oakland Schools will be holding a local wellness policy workshop for school districts.
- Gleaners is requesting opportunities to have a table at community events and disburse nutrition education information. Kelsey will share information on HOP Family and Senior Market Days.
- United Way is advocating for Healthy School Meals for All (i.e. Universal School Meals).
