- a. Oakland County Flag Egbo: BOC to create a new flag in time for America 250 next year; OCHC should have a voice on the committee and support the BOC in this process. Decker will contact Dave Woodward about joining the BOC flag committee.
- b. OCHS Summer Social Planning Oakland County Historical Society is the new name for former Oakland County Pioneer & Historical Society. Summer Social is July 26 & 27, 12pm-4pm. Decker is not available to set up; two tables, tent, and bin of OCHC materials will be in the mansion basement, maybe set up on Friday, instead of Saturday, if possible. - c. Circuit Court History America 250; Judge Warren picked Circuit Court History as the project; Egbo is on the history committee. Decker can help with research.
- d. Underground Railroad in Pontiac Darrow & Peck Subdivision, Deeds (Decker) – Egbo is helping someone research a possible Pontiac enclave that provided safety for freedom seekers between 1850-1860; Decker found some land records related to Crockett in this subdivision (1850 deed from Weeks to Crockett), can look at census neighbors for 1850 to see who lived around him

- b. Juneteenth Report: Well-attended and lots of people came by the OCHC, event cut short by weather. The 1877 book was a big draw; Egbo suggests putting them in a binder alphabetically to make it easier to find each Twp.; Richardson suggests having a couple copies of them
- c. May Preservation Month Social Media Engagement was good; can we put together a posting schedule in time for America 250, could highlight history of the county population growth; try to tie county history to national picture without being overly academic, maybe how did Oakland County's

Revolutionary War veterans get here, their families moving from the east coast to this area; aim for 4 posts/mo., could we get an intern to help with this? Could each community provide images/info and post to our page?

Richardson and Decker suggest picking a theme for each month (such as January = Winter in Oakland County; February = Ice Harvest; March = Roads)

- d. 5 Year Plan <u>Awards Program, Workshop Planning, Website, Youth Engagement, Data Collection on Historical Sites</u> are some goals
 - i. Awards program need to flesh out Pewabic tile awards
 - ii. Workshop probably not for 2025, aim for 2026; should OCHC be a session presenter at next Local History Conference? Need to figure out what our topic would be...
 - iii. Website need to identify improvements we can make, such as a better finding aid directory, as well as visitors and tourism, and directing them to points of interest in the county, make a Storymap with ArcGIS?
 - iv. Youth Engagement Richardson suggests a poster contest to drive interest; Murphy suggests schools might have students do this for America250 anyway; Deckers suggests an AI-prompting contest that will give you an *accurate* answer about Oakland County history (we experimented with Claude.ai and got "Pastoral Pursuits," a meditation on sheep farming in Oakland County, and also an Oakland County sheep rap)...and for our 5 year plan in general, be thinking about how we could teach people to research and present history with AI—maybe this could be a workshop topic for us
