Good Morning All,

The Courts Justice Leadership Group (Oakland County Prosecutor's Office) is requesting an eVote approval to move 100 hours from the Court's Mandate Program Budget to the Prosecutor's Enhancement Budget to implement the changes required for the Prosecutor Switch effective January 1st, 2021.

This change will accommodate modifications to 20 Mainframe programs to convert the Prosecutor name from Jessica Cooper to Karen McDonald. In addition, this effort will ensure that cases and calendar entries are updated to reflect the switch. There are 660 unallocated hours in Court's Mandate Program Budget at this time.
