 - Reguest to Move 200 hours from the Property Gateway Roadmap Project #22 to the CAMS Enhancement Budget #27-Approved Tammy spoke: descoping deliverables reducing the scope to be less so that can allocate that time due to limited resources to start property gateway. Time leftover for the upgrade.
 - Remove the Mobile Assessment Data Collection Project #26 from the Master Plan (992 hours).
