YMCA

- YMCA will be providing meals to children 18 years and younger, and young adults with special needs up to age 26
- Lunch and breakfast provided, and parents/children can take 4 days' worth of meals at one time
- Children do not need to be present for parents to pick up meals

Oakland County Farmers Market

Taste the Local Difference (TLD)

- Kelly is also concerned for the farmers

Fair Food Network (FFN)

- Markets that are remaining open are moving markets outdoors and providing additional hand sanitizer
- FFN is assessing how DUFB can be used to support farmers during this time
