## MAGISTRATE PLAN FOR HOLIDAY PROCEEDINGS

#### IT IS ORDERED:

Due to extenuating circumstances, the  $51^{st}$  District Court is hereby added to the  $52^{nd}$ District Court's holiday arraignment program. This order is in conjunction with the 52<sup>nd</sup> District Court's Local Administrative Order 1995-01J, Magistrate Multiple District Plan for Weekend Arraignments. The holidays that this service provides are the official holidays of Oakland County Government and are in conformance with MCR 8.110.

#### IT IS FURTHER ORDERED:

The magistrates of the 52<sup>nd</sup> District Court are authorized to conduct arraignments, set bail or recognizance, provide for appointment of counsel, make determinations of probable cause and issue warrants for the 51st District Court on holidays.

#### IT IS FURTHER ORDERED:

The magistrates under this plan are appointed by the Chief Judge of the 52<sup>nd</sup> District Court. The magistrates under this plan have been appointed pursuant to MCL 600.8501 and nothing in this plan shall grant powers or duties to the district court magistrates that are not authorized by statute or that exceed the authorization of the Chief Judge of the 52<sup>nd</sup> District Court. The magistrates will conduct the proceedings at the Sixth Circuit Court facility or such other place that shall be designated, from time to time, by the Chief Judge of the 52<sup>nd</sup> District Court within the county seat. All expenses for such magistrates, support personnel, supplies and other items necessary to conduct these proceedings shall be the responsibility of the 52<sup>nd</sup> District Court.

The magistrates under this plan are subject to the superintending control of the Chief Judge of the 52<sup>nd</sup> District Court.
