## PLAN FOR JUDICIAL OFFICER AVAILABILITY FOR WEEKEND FELONY ARRAIGNMENTS

## ADMINISTRATIVE ORDER 1988-1

The purpose of this document is to set forth a plan to assure the availability of a Magistrate for the purpose of **SATURDAY AND SUNDAY FELONY ARRAIGNMENTS ONLY** within the Sixth Judicial Circuit.

Presently the 52nd District Court has a Magistrate for Saturday arraignments held at the County Courthouse between the hours of 9:00 a.m. and 1:00 p.m.

The Oakland County Board of Commissioners has approved the position of Magistrate for Sunday felony arraignments for the 52nd District Court to be held at the County Courthouse between the hours of 9:00 a.m. and 1:00 p.m.

The Board of Commissioners approved this Sunday Magistrate with the condition that said Sunday Magistrate in addition to the Saturday Magistrate be available to all District Courts in Oakland County for **SATURDAY AND SUNDAY FELONY ARRAIGNMENTS ONLY** during the above mentioned hours.

The plan will be implemented upon agreement of the Chief Judge of the Sixth Judicial Circuit and the Chief Judge of each District Court with the County of Oakland.

By accepting and approving this plan there will be no mandatory requirement for any District Court to use said Magistrate but that said Magistrate will be available if desired.

There shall be no charge to the funding unit of any District Court, excepting the 52nd District Court, for this service.

By executing this plan each Chief Judge of a District Court hereby appoints said 52nd District Court Magistrate as a Magistrate of their respective Court for **SATURDAY AND SUNDAY FELONY ARRAIGNMENTS ONLY** and to be conducted at the County Courthouse, Pontiac, Michigan.
