

ORDER AUTHORIZING SIGNATURES OF DEPUTY PROBATE REGISTERS


IT APPEARING TO THE COURT that pursuant to Michigan Court Rule 5.602(B) that the Probate Court may by an Administrative Order authorize Deputy Probate Registers to sign or by device indicate the name of a judge to all orders and letters of authority of the court, with the same force and effect as though the judge had signed them, as long as the Deputy Probate Register's initials are under the judge's name.


NOW, THEREFORE, IT IS HEREBY ORDERED that the Oakland County Probate Court by this Administrative Order authorizes the Deputy Probate Registers to sign the attached list of orders and letters

of authority, with the exception of orders resulting from contested matters, which must be signed by the judge, and with a further instruction that no Bench Warrants, Orders to Take Into Custody, Emergency Transport Orders, or Certificates of Marriage shall be signed by a Deputy Probate Register.
