THEREFORE, the Deputy Probate Registers are authorized to sign the attached lists of orders and letters of authority. These lists may be amended from time to time with the approval and upon the order of the Chief Judge. Orders resulting from contested matters, Emergency Transport Orders, and Certificates of Marriage must be signed by the Probate Judge, and the Deputy Probate Registers are without authority to sign these documents.
