### INFRASTRUCTURE - IT PROJECTS UPDATE

Mr. Timm gave the members a plan of what the left over \$300,000 from the bond proceeds with be utilized on. Mr. Meisner asked what bond language the left-over money falls under. Ms. Phelps stated there is a line item in the bonds that reads technology equipment, basically a very general broad description. Ms. Hage stated we are being asked to approve this left-over bond money for IT equipment when we haven't even seen the bond paperwork to assure this meets the scope. Ms. Hage suggested we develop a process for left over bond money. Ms. Hage suggested we request bond counsel to submit a memo to the Building Authority stating the left-over bond money meets the scope of the bonds.

The committee agreed to table the approval of the bond money being used for IT equipment until a memo is received from bond counsel.

It was moved by *Ms. Hage* and seconded by *Mr. Meisner* to request anytime a bond issuance is done and under the purview of this board, bond counsel will issue a memorandum to this board as to the scope and uses of what the bond can be used for.
